Haryana Public Service Commission vide its Advertisement No. **Advt No. 27/2023** dated 24.06.2023 had advertised 580 posts of **Post Graduate Teacher (PGT) in the subject of Fine Arts for Rest of Haryana Cadre, in Secondary Education Department, Haryana.** The subject knowledge test was conducted on 17.09.2023 in which 290 no. of candidates appeared out of 420 total applicants.
