- 1. The DSSSB vide its advertisement no. 07/22 with closing date 27/08/2022 had advertised 18 (Eighteen) vacancies (EWS-01, UR-09, OBC-05, SC-02, ST-01 including PH(HH-01, OH-02)) for the Post of Deputy Manager (Accounts) in under post code 14/22 in Delhi Transport Corporation, GNCTD.
- 2. The written examination (online mode) Tier-I for recruitment in respect of this post was conducted on 25th June, 2023.
- 3. The marks obtained by 207 candidates who have duly appeared in written examination held on 25th June, 2023 have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on <a href="https://www.dsssbonline.nic.in">www.dsssbonline.nic.in</a>.
- 4. Based on the performance in Tier-I examination (Online Mode), out of the 207 candidates, a total of 27 (Twenty Seven) candidates as detailed below have been provisionally shortlisted to appear in the Tier-II Examination to be conducted by DSSSB subject to their attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form. The shortlisted candidates shall be called for Tier-II Examination separately.
